When the Union notifies AGC of Illinois of its request, whereupon an addendum in writing describing such change(s) shall be incorporated in this agreement. It is further agreed that the Mid-America Carpenters Regional Council shall send Illinois Department of Labor Prevailing Wage Certification forms to the Egyptian Contractors Association and the Associated General Contractors of Illinois for review prior to submission to the Illinois Department of Labor.
